

## **Terms and Conditions – BBXI Guess the Number Plate Promotion**

### Draw 1 – Become a new member of BBX

1. Each new member after payment and processing will receive one SMS to click on link to enter competition, once the PLATE NUMBER is entered that MEMBER ACCESS will be disabled to avoid FRAUD
